Study may help design better cochlear implants

he way in which we experience music and speech differs from what has until now been believed. This is the conclusion of a study by researchers at Linkoping University, Sweden, and the Oregon Health and Science University, USA. The results published recently may make it possible to design better cochlear implants.

We are social creatures. The sound of other people's voices is important for us, and our hearing is directed at experiencing and distinguishing voices



and human speech. Sound that arrives at the outer ear is carried by the ear drum to the spiral-shaped inner ear, also known as the cochlea. The sensory cells of hearing, outer and inner hair cells, are located in the cochlea. The sound waves cause the "hairs" of the inner hair cells to bend, sending a signal through the nerves to the brain, which interprets the sound we hear.

For the past 100 years, we have believed that each sensory cell has its own "optimal frequency" (a measure of the number of sound waves per second). The hair cell responds most strongly to this frequency. This idea means that a sensory cell with an optimal frequency of 1000 Hz would respond much less strongly to sounds with a frequency slightly lower or higher. It has also been assumed that all parts of the cochlea work in the same way. Now, however, , a research team has discovered that this is not the case



for sensory cells that process sound with frequencies under 1000 Hz, considered to be low-frequency sound. The vowel sounds in human speech lie in this area.

"Our study shows that many cells in the inner ear react simultaneously to low-frequency sound. We believe that this makes it easier to experience low-frequency sounds than would otherwise be the case, since the brain receives information from many sensory cells at the same time," says Anders Fridberger, professor in the Department of Biomedical and Clinical Sciences at Linkoping University.

The scientists believe that this construction of our hearing system makes it more robust. If some sensory cells are damaged, many others remain that can send nerve impulses to the brain.

It is not only the vowel sounds of human speech that lie in the low-frequency region: many of the sounds that go to make up music also lie here. Middle C on a piano, for example, has a frequency

These results may eventually be significant for people with severe hearing impairments. The most successful treatment currently available in such cases is a cochlear implant, in which electrodes are placed into the cochlea.

"The design of current cochlear implants is based on the assumption that each electrode should only give nerve stimulation at certain frequencies, in a way that tries to copy what was believed about the function of our hearing system. We suggest that changing the stimulation method at low frequencies will be more similar to the natural stimulation, and the hearing experience of the user should in this way be improved," says Anders Fridberger.

Precise gene correction for retinal

diseases

In a new paper, University of California, Irvine researchers explain how precision genome editing agents have enabled precise gene correction and disease rescue in inherited retinal diseases (IRDs). The study, titled, "Precision genome editing in the eye" was published recently.

The paper describes current preclinical successes and clinical genome editing approaches for treating inherited retinal degenerative disease and stresses there is hope that in vivo gene editing will be the future treatment paradigm for IRDs. Currently, there are no effective treatments for these devastating diseases, which commonly result in blindness.

"Genome editing technologies are an excellent approach for targeting the root causes of genetic disorders," explained Krzysztof Palczewski, PhD, Donald Bren Professor of Ophthalmology at the UCI School of Medicine and corresponding author. "Technologies in genome editing have continuously evolved to enable precise genome editing with fewer side effects and risks, making precision genome editing possible."

The paper describes progress toward using genome editing for treating IRDs and important considerations for robust clinical translation.

"More and more CRISPR-based treatment approaches are being tested in clinical trials," said Palczewski. "We believe that there will be an increasing number of clinical trials for targeting IRDs and that any mutation that causes them will be amenable to treatment with this approach."

Programmable CRISPR-Cas nucleases are effective tools for gene disruption, but they are poorly suited for precisely correcting pathogenic mutations in most therapeutic settings. Improvements are needed for clinical translation.

Inherited retinal diseases (IRDs) are a genetically heterogeneous group of blinding disorders characterized by a progressive degeneration of the photoreceptors as well as the retinal pigment epithelium (RPE). These disorders affect ?1 in 3,000 individuals worldwide and profoundly impact patients' quality of life. IRDs are caused by mutations in genes that are critical for development and/or function of the retina or RPE, and more than 270 causative genes have been identified.

Over the past two decades, major advances in gene therapy have engendered new hopes for successful treatment of these IRDs. Most recently, precision genome editing agents, including base editors (BEs) and prime editors (PEs), developed by The Liu Lab, have enabled efficient and precise target gene correction, rather than gene disruption, in various therapeutic settings, including mouse models of IRDs. Precise target gene correction greatly expands the potential therapeutic applications of genome editing technologies, since most genetic disorders cannot be treated by gene disruption.

"Precision medicine for IRDs has a promising outlook, as basic science has consistently led to the development of therapeutic tools to target patientspecific genetic mutations," said Palczewski. "The results of initial clinical trials, that use in vivo gene editing to treat IRDs, will be essential for informing the design and translation of future precision genome editing therapies."

Wearable sensors styled into **T-shirts & face masks**

Imperial researchers have embedded new low-cost track liver and kidney function. The ammonia sensors sensors that monitor breathing, heart rate, and ammonia into T-shirts and face masks.

Potential applications range from monitoring exercise, sleep, and stress to diagnosing and monitoring disease through breath and vital signs.

Spun from a new Imperial-developed cotton-based conductive thread called PECOTEX, the sensors cost little to manufacture. Just \$0.15 produces a metre of thread to seamlessly integrate more than ten sensors into clothing, and PECOTEX is compatible with industry-standard computerised embroidery machines.

First author of the research Fahad Alshabouna, PhD candidate at Imperial's Department of Bioengineering, said: "The flexible medium of clothing means our sensors have a wide range of applications. They're also relatively easy to produce which means we could scale up manufacturing and usher in a new generation of wearables in clothing."

The research team embroidered the sensors into a face mask to monitor breathing, a t-shirt to monitor heart activity, and textiles to monitor gases like ammonia, a component of the breath that can be used to

were developed to test whether gas sensors could also be manufactured using embroidery.

Fahad added: "We demonstrated applications in monitoring cardiac activity and breathing, and sensing gases. Future potential applications include diagnosing and monitoring disease and treatment, monitoring the body during exercise, sleep, and stress, and use in batteries, heaters, anti-static clothing."

The research is published today in Materials Today. Wearable sensors, like those on smartwatches, let us continuously monitor our health and wellbeing non-invasively. Until now, however, there has been a lack of suitable conductive threads, which explains why wearable sensors seamlessly integrated into in

clothing aren't yet widely available.

Enter PECOTEX. Developed and spun into sensors by Imperial researchers, the material is machine washable, and is less breakable and more electrically conductive than commercially available silver-based conductive threads, meaning more layers can be added

for to create complex types of sensor. Lead author Dr. Firat Guder, also of the Department



of Bioengineering, said: "PECOTEX is high-performing, strong, and adaptable to different needs. It's readily scalable, meaning we can produce large volumes inexpensively using both domestic and industrial computerised embroidery machines.

"Our research opens up exciting possibilities for wearable sensors in everyday clothing. By monitoring breathing, heart rate, and gases, they can already be seamlessly integrated, and might even be able to help diagnose and monitor treatments of disease in the future."

Next, the researchers will explore new application areas like energy storage, energy harvesting and biochemical sensing, as well as finding partners for commercialisation.

Goldfarb and his team found they could toggle megakaryocytes between their infant and adult modes - between making factories or making platelets - by blocking a particular enzyme, Dyrk1a. Need more factories? No

Patients often receive cord-blood transplants when they cannot find a suitable donor for stem-cell transplants. Finding a donor can be especially challenging for people of African, Asian, Hispanic, Middle Eastern, southern European or mixed ethnic backgrounds.

The discovery could also lead to new treatments for thrombocytopenia, a condition in which the body has too few platelets. This can be the result of immune system problems, a bone marrow disorder such as leukemia (blood cancer), some viral infections or the use of certain medications. Thrombocytopenia is a particular problem for premature babies - the more premature the baby is, the more severe the condition tends to be.

New research on matters relating to skin

Why are certain body parts more prone to skin diseases than others? Two new UC Davis Health studies explored how differences in skin composition may lead to dermatological conditions, such as psoriasis and atopic dermatitis.

"Skin does not have a uniform composition throughout the body," said Emanual Maverakis, professor of dermatology, molecular medical microbiology at UC Davis and senior author on both studies. "Different skin characteristics at different body sites may affect the skin's susceptibility to certain diseases.

Skin diseases affect about 84.5 million Amerienvironmental and genetic factors can lead to a wide range of skin conditions.

The skin is the largest organ in the body. It has an average area of about 20 square feet - that's the size of a 4' by 5' room! Its outermost layer (epidermis) has a lipid matrix composed of free fatty acids, cholesterol and ceramides (a family of waxy lipid molecules).

This layer must meet the environmental challenges specific to each area of the body. For example, the skin of the face needs to be thin and flexible to accommodate facial expressions. The skin covering the heel of the foot has to be thick

> Until recently, little was known about the cellular and molecular processes behind these differences. In the first study, researchers showed the mechanisms that lead to these structural changes in the skin.

The epidermis has a "brick and mortar" structure: molecules like ceramides, cholesterol and fatty acids make up the "mortar," and cells called keratinocytes are

the "bricks."

The researchers used single-cell sequencing to characterize how the keratinocytes differ at different body sites. They also used targeted molecular profiling to characterize the molecules that form the "mortar" between looks so different at dif-

the keratinocytes. They then examined how these differences in gene expression matched the compositional differences in the lipid and protein structures across body sites. These experiments explained why the skin

The compositional differences in the skin's lipids and proteins across different body sites may also explain why different skin diseases are found at different body sites. While characterizing the specific lipid alterations associated with various skin diseases, the researchers discovered that lipids stuck to a piece of tape applied to the skin were sufficient to diagnose a patient with a particular skin disease.

"These discoveries will lead to non-diagnostic tests for common dermatologic disease" said co-lead author, Project Scientist Alexander Mer-

"These differences are also relevant to the future design of skin care products," said Stephanie Le, dermatology resident and co-lead author of the study. "They demonstrate how skin care products should be specifically formulated to match the particular body site that they will be applied to." In the second study,

the research team studied how skin cells interact with the immune system. Previously, it was

known that keratinocytes could secrete substances that both increase and decrease inflammation. Using single-cell sequencing to analyze each kera-

these immune-modulating molecules were expressed in certain layers of the epidermis."Our discovery that different layers of the skin secrete different immune mediators is an example of how the skin is highly specialized to interact with the immune system. Dravidian model of governance believes in India's growth: Stalin

TN stands No. 2 in the country in terms of State GDP

Chennai, Sept 27: The Dravidian model of governance believes in India's growth, and Tamil Nadu has shaped the future of the country, said chief minister MK Stalin at the CNN-News18 Town Hall in Chennai on Monday, adding that the state is synonymous with inclusivity.

"Tamil Nadu is the first state to bring law against caste discrimination... In poverty parameters, Tamil Nadu's is the lowest among all states," Stalin said at the event.

According to a multi-dimensional poverty index (MPI) report prepared by Niti Aayog, Tamil Nadu has the fourth lowest poverty index (4.89%) after Goa (3.76%), Sikkim (3.82%) and Kerala (0.71%).

Stalin also praised the state's economy, saying it is No. 2 in the country in terms of state GDP. "We

people's increasing standard (of living)," said Stalin.

Maharashtra, Tamil Nadu, Karnataka, Uttar Pradesh and Gujarat constituted about 40% of the country's nominal GDP in FY22, according to a report.

"Individual income is higher here (Tamil Nadu) compared to other states. No one here dies due to unavailability of food. There is only 4% of the total population that falls in the BPL category," said Stalin.

Stressing on government schemes for Tamilians, Stalin said the free bus ride travel for working women in government buses or select routes has been a "tool for women empowerment".

He also drove attention towards Tamil Nadu contributing for bringing coalition government in the country. The state had its first don't compare export and import coalition government in 1952 after the CM stressed.

TN to give subsidy for manufacture of alternatives to banned plastic items: Minister

Chennai, Sept 27: Tamil Nadu will implement the extended producer's responsibility to ensure non-biodegradable plastic doesn't end up in landfills. It would also implement subsidy models to encourage manufacture and sale of alternatives to banned plastic material, minister for environment and climate change Siva V Meyyanathan said.

Meyyanathan was speaking at a national workshop on eco-alternatives that was held at Chennai Trade Centre.

He said Anna University and IIT-Madras had already begun studies on replacements for the Aavin milk packets. Aavin delivers 25 lakh litres of milk every day.

"We have ordered all districts

to collect plastic waste dumped on roadsides and dispose of them scientifically," he said.

Meyyanathan said the state was committed to implement the plastic ban imposed in January 2019 and so far 174 industries had been shut down permanently, over 1,200 tonne of plastic had been seized and about Rs 110 crore was imposed as penalty.

The national workshop and expo was held by the Tamil Nadu pollution Control Board along with the Union ministry of environment and climate change. Everything from sanitary pads to packaging materials, combs and bottles to toothbrush made from bamboo, neem and other alternative material were available

Around 168 stalls for eight categories of products from manufacturers and self-help groups from all states including Jammu and Kashmir were on display.

A directory of manufacturers involved in eco-alternatives was also released.

Supriya Sahu, additional chief secretary for environment department, said the workshop was mainly held to start discussing the solutions instead of talking about problems that plastic caused on the environment and wildlife.

"Hotels, industries, finance institutions and startups have been brought under one roof to help each other in implementing the plastic ban and looking at alternatives as a solution," she said.

SC seeks Govt stand on Rajiv Gandhi assassin's plea for early release New Delhi, Sept 27:

The Supreme Court Monday sought responses from the Centre and the Tamil Nadu government on a plea filed by Nalini Sriharan, serving life sentence in the Rajiv Gandhi assassination case, seeking premature release.

A bench of Justices BR Gavai and BV Nagarathna issued notices to the Centre and the Tamil Nadu government and sought their replies on the plea. The top court also issued notices on the plea filed by RP Ravichandran, who is also a convict in the case.

Nalini has challenged the June 17 order of the Madras high court, which rejected her plea for early release, and cited the apex court judgment ordering the release of co-convict AG Perarivalan. The HC had on June 17 rejected the petitions of Sriharan and Ravichandran, both convicted in former PM Rajiv

Gandhi assassination case, to order their release without even the consent of the state's governor.

The HCs do not have the power under Article 226 of the Constitution to do so, unlike the Supreme Court which enjoyed the special power under Article 142, the HC had said while rejecting their pleas.

Invoking its extraordinary power under Article 142 of the Constitution, the top court had on May 18 ordered the release of Perarivalan, who had served over 30 years in jail, and said the Tamil Nadu governor ought not to have sent the "binding" advice made by the state cabinet for his release to the president. The apex court had said the advice of the state cabinet is binding on the governor in matters related to commutation/remission of sentences under Article 161 of the Constitution.

do visit the districts assigned to you more than once. You should stay there and inspect school buildings and relief centres. You should specifically focus on school buildings," Mr. Stalin said.

The Chief Minister advised officials to prevent inundation in Chennai. "This time around, I am expecting that there would not be any inundation in key areas. At the same time, you should not be careless too."

The officials were told to ensure synergy among government departments and emphasised the need for roping in resident welfare associations while undertaking precautionary measures. He instructed the officials to complete

"Last time, there was some delay in receiving monsoon-related alerts. This time, you should not only receive such alerts on time but also consider resources from private monsoon observers and undertake precautionary measures accordingly," Mr. Stalin stated.

The Chief Minister advised authorities to ensure supply of drinking water, electricity, medicines and other health supplies when people are moved to relief camps, and it was the official duty to ensure people's safety and well-being. A nodal officer was to be appointed for every relief camp, he said.

Stalin also underlined the need for making more people aware of the helpline numbers.
